- _____ I am aware that I can bring a generator if I need power but that it has to be a Honda, (or equivalent) 'quiet version' generator. If you have to talk over it to have a conversation, it's too loud and will not be acceptable.
- _____ I understand that the SC BBQ Shag Festival only provides the space that is on the application. If I need anything else, including but not limited to tents, tables, chairs, etc., I must bring it with me.
- _____ I understand that I will only receive **ONE** parking sticker per crafter space for the vendor/crafter parking area and any additional vehicles must be parked elsewhere. (We do not have the parking space for more than one vehicle per crafter space.)
