We would like to thank you for your interest in attending The 27th Annual South Carolina BBQ Shag Festival. As always, it is our full intent to make this event as prosperous and enjoyable as possible. To help make this happen, it is imperative that we receive a brief description of your merchandise and a picture, (if possible), so that we may arrange the spaces of vendors to avoid duplication.

Each Vendor space includes water and electricity, 110v with 20 amp GFI circuit. If more amp's are needed please indicate how much, up to an additional 10 amps. Extra amps, (up to 10) are an additional \$50.00. Spaces with additional power are extremely limited, (with extra power being even more limited), and are on a first come first serve basis. A deposit of 100% of the rent space is required on all reserved vendor spots. Applications and deposits are required by April 1st , 2015.

Space price does NOT include town permit. Permit application is attached and must be filled out and sent along with application.

Check in will begin at 10:00 A.M. on Friday, April 17th until 4:00 P.M.

No one will be allowed to set up after 5:00 P.M. on Friday, April 17th and vehicles must be out of the area by this time.

You may set up on Thursday, April 16th AFTER 5:00 P.M., however there is little to no crowd in the vendor/crafter area on this night.

_____ I understand that I will only receive **ONE** parking sticker per vendor space for the vendor parking area and any additional vehicles must be parked elsewhere. (We do not have the parking space for more than one vehicle per vendor space.)

I understand all of these rules and also understand that they may be changed at any time or added to. My staff and I agree to abide by these rules and understand that any violation of the rules and regulations of the festival will result in termination of our space without refund of any fees paid.
